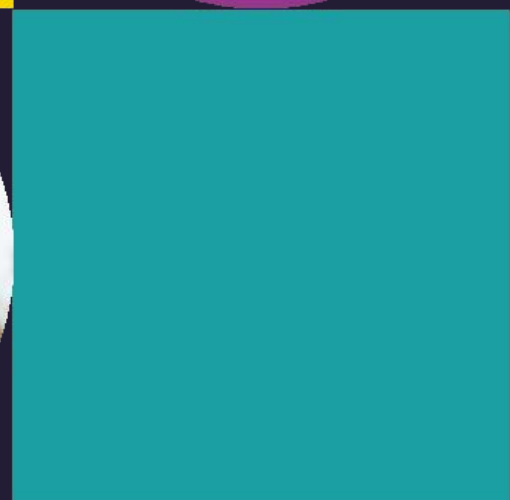
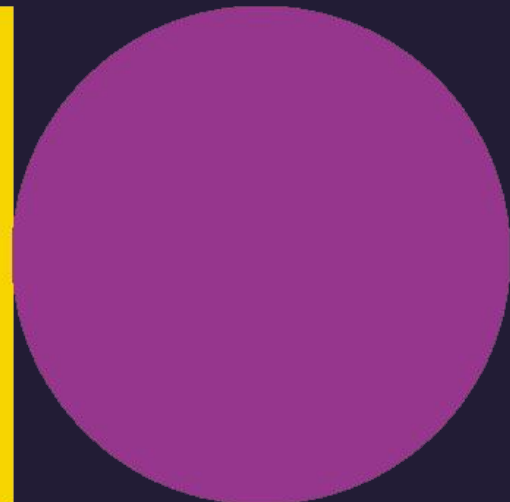

2026 PayPoint RAGS and TAGS Terms



PART A: TERMS AND CONDITIONS

1. Definitions and Interpretation

In these Terms, capitalised terms have the meanings given in the Contract Particulars unless otherwise defined.

2. Appointment and Services

2.1 PayPoint agrees to provide the advertising services selected in the Contract Particulars (the Services) via the PayPoint terminal network, subject to these Terms.

2.2 Nothing in these Terms obliges PayPoint to provide any services other than those expressly selected in the Contract Particulars.

3. Campaign Term

3.1 The Campaign shall run for the time period (the Campaign Term) indicated in the Contract Particulars.

3.2 The Campaign shall not commence unless and until PayPoint has received the Advertiser's written approval of the final advert.

4. Advert Content and Approval

4.1 The form, design and content of all advertisements must be agreed in writing with PayPoint in advance.

4.2 PayPoint may refuse to display, suspend or remove any advertisement which, acting reasonably, it considers: (a) unlawful, misleading or non-compliant; or (b) detrimental to PayPoint, its brand, customers or agents.

4.3 The Advertiser warrants that all advert content complies with applicable law, including consumer and advertising regulations.

5. Placement and Delivery

5.1 Advertisements shall be displayed during the Campaign Term at the locations and using the media described in the Contract Particulars.

5.2 Any reach or location figures provided are estimates only and are not guaranteed.

6. Fees and Payment

6.1 The Advertiser shall pay the Fees set out in the Contract Particulars.

6.2 Fees are exclusive of VAT, which shall be charged at the prevailing rate.

6.3 PayPoint may suspend the Campaign for non-payment without liability.

7. Compliance and Responsibility

7.1 The Advertiser is solely responsible for ensuring the advertisement complies with all applicable laws and advertising standards.

7.2 PayPoint gives no assurance or warranty as to consumer response or campaign effectiveness.

8. Termination

8.1 PayPoint may terminate or suspend the Campaign immediately if: (a) complaints are received relating to the advert or advertising method; or (b) continued display presents legal, regulatory or reputational risk.

8.2 Termination shall be without prejudice to accrued rights.

9. Confidentiality

Each party shall treat as confidential all confidential or proprietary information received from the other party in connection with the Campaign or these Terms and shall not disclose such information except as required by law or for the purposes of performing these Terms

10. Limitation of Liability

10.1 Subject to clause 10.2, PayPoint's total liability arising out of or in connection with the Campaign shall not exceed the Fees paid.

10.2 Nothing limits or excludes liability for fraud or any liability which cannot legally be excluded.

11. Governing Law and Jurisdiction

These Terms and any dispute arising from them are governed by the laws of England and Wales and subject to the exclusive jurisdiction of its courts.
